

INCREASE their own industrial CFC production. The new treaty demands an immediate freeze, followed by a huge reduction of American production and consumption of CFC products. Thus, the new ozone treaty serves the interest of the Trilateral-allied international bankers by promoting the deindustrialization of America.

The September 15, 1987 WALL STREET JOURNAL described the economic devastation inside America that will result from the new ozone treaty: "The economic impact of the cap (freeze on production) alone would be huge, WITH PRICES AT LEAST DOUBLING FOR EXISTING COMPOUNDS." Industry officials predict that U.S. consumers will be forced to pay tens of billions of dollars more for such products as insulation, air conditioning, refrigeration, cleaning agents, and high tech fire suppressants (used to protect airplanes and computers). None of these American economic sacrifices will do ANYTHING to stop the depletion of the ozone layer, since they are totally UNRELATED to the real cause of the sudden ozone loss since the 1976 start of Soviet Tesla ELF transmitters.

NEW SCIENTIFIC DISCOVERIES FORCE MAJOR REVISIONS IN ELECTROMAGNETIC THEORY AND SUPPORT TESLA

Nikola Tesla based his work upon theoretical concepts of electromagnetic waves that had significant DIFFERENCES with classical Maxwell wave concepts. Because most U.S. scientists were educated and trained only in traditional Maxwellian wave characteristics, they frequently have not been able to understand the work of Nikola Tesla.

THE ENTIRE BASIS OF ELECTROMAGNETIC LAW IS NOW BEING REVISED, confirming Nikola Tesla's theoretical works. The April 6, 1987 ELECTRONIC ENGINEERING TIMES reported:

"Futuristic weaponry being developed for defense programs like the Strategic Defense Initiative MAY END UP SHOOTING MORE HOLES IN PHYSICAL THEORY THAN IN ENEMY MISSILES. The Lorentz Force Law (which links the physical forces on conductors to the electric current coursing through them) has become a casualty of electromagnetic railgun research."

"Anomalies between the predictions of Lorentz theory and the actual forces between conductors carrying extremely high currents in these new types of guns have appeared in related research conducted at the Massachusetts Institutes of Technology."

The anomaly, with the Lorentz force law, ONLY SHOWS UP AT THESE HIGH CURRENTS, WHICH IS WHY THE LAW HAS STOOD UP UNDER EXPERIMENTAL SCRUTINY FOR SO LONG. But conclusive evidence of the law's failure has been shown..."

This so-called "basic law of electromagnetic theory" has been WRONG FOR 80 YEARS and all U.S. scientists and engineers have been EDUCATED ON THE BASIS OF THIS FALSE THEORY.

The professional engineering journal stated, "POSSIBLY MORE REVISIONS OF ELECTROMAGNETIC THEORY ARE PENDING."

The September 14, 1987 ELECTRONIC ENGINEERING TIMES reported that Domina Spencer, an electromagnetic theorist at the University of Connecticut stated, "Since the turn of the century, there has been a lot of first class experimental and theoretical work that reveals PROBLEMS WITH RELATIVISTIC ELECTROMAGNETIC THEORY, BUT THIS WORK HAS BEEN VIRTUALLY IGNORED BY THE MAINSTREAM PHYSICIST."

Northeastern University physicist Peter Graneau has shown that OBJECTS MOVE, BUCKLE, AND BREAK UNDER FORCES THAT ARE NOT FOUND IN CURRENT ELECTROMAGNETIC EQUATIONS."

Graneau's discovery explains the total inability and refusal of U.S. liberal establishment scientists to recognize Soviet scalar weapon zapping of more than NINE U.S. rockets, that have been destroyed since August 25, 1985 (see Col. Thomas Bearden's book FER-DE-LANCE and the 12/86 and 5/87 YOUTH ACTION NEWS for documentation).

Physicist Domina Spencer is now embarked "on an ambitious project of REVIEWING ALL THE EXPERIMENTAL WORK THAT HAS BEEN PERFORMED ON ELECTROMAGNETIC PHENOMENA SINCE 1824, WHEN AMPERE PUBLISHED HIS FIRST RESULTS."

The ELECTRONIC ENGINEERING TIMES stated, "Now in the latter decades of the 20th century, EXPERIMENTAL RESULTS THAT CANNOT BE EXPLAINED BY ACCEPTED THEORY ARE BEGINNING TO PILE UP..."

The ELECTRONIC ENGINEERING TIMES made an extremely important statement: "...Current-element analysis ...EXPLAINS THE EXISTENCE OF THE LONGITUDINAL ELECTROMAGNETIC WAVES" (GIANT STANDING WAVES CREATED TODAY BY TESLA MAGNIFYING TRANSMITTERS) "that were observed by radio pioneer NIKOLA TESLA. BECAUSE SUCH WAVES CANNOT BE DERIVED FROM MAXWELL'S EQUATIONS, TESLA'S EXPERIMENTS WERE IGNORED..."

U.S. PATENT OFFICE PROVIDES NEW PROOF OF ELECTROMAGNETIC WEATHER CONTROL AND SCALAR WEAPONS

Because of the secret polar warming agreement involving joint U.S.-Soviet weather-engineering, the U.S. Government has repeatedly denied that it was even possible to control the weather with electromagnetism. But, due to intense bureaucratic rivalry between various Federal agencies, the U.S. Patent Office refused to maintain the secret cover-up about the new U.S. electromagnetic weather control patent, just granted to ARCO, a giant multinational oil company, allied to the international bankers.

Government secrecy on this electromagnetic weather engineering system was blown on August 11, 1987, when the U.S. Patent Office granted Patent Number 4,686,605 to Dr. Bernard J. Eastlund. The August 15, 1987 NEW YORK TIMES reported that Dr. Eastlund is "a physicist and an expert on oilfield development, who is a consultant for the Atlantic Richfield Oil Company (ARCO). ... Mr. Eastlund assigned the patent rights to APTI, Inc., a Los Angeles subsidiary of Atlantic Richfield."

On September 6, 1987, the National Public Radio show, "All Things Considered," carried an interview with Dr. Eastlund. NPR reported: "Dr. Eastlund stated that his new invention COULD BE USED TO CHANGE THE WEATHER BY REDIRECTING THE VERY HIGH WIND PATTERNS."

"The invention would use an earth-based power source to create electromagnetic radio waves and focus them way up in the Atmosphere. Dr. Eastlund says the invention could STEER JET STREAMS, but could also be used to DISRUPT COMMUNICATIONS ALL OVER THE WORLD, and perhaps, most significantly--MIGHT BE USED TO DESTROY OR DEFLECT A MISSILE ATTACK."

All of these characteristics describe EXACTLY what the Soviet Tesla-scalar weapons have been doing to the United States since 1976, including the deliberate zapping of more than 9 U.S. rockets since August 28, 1985.

In his NPR interview Eastlund stated, "I am not happy, personally that the patent was issued publicly. THIS PARTICULAR PATENT WAS UNDER AN INITIAL SECRECY ORDER BY THE PATENT OFFICE. But, as I understand it, the Patent Office does not keep secret, basic fundamental information, which they interpreted this patent to be. SPECIFIC DISCUSSION OF MILITARY APPLICATIONS IS SECRET--PROPRIETARY ALSO. It's what they wanted to do."

On the front page of the official Eastlund-ARCO patent, there are clearly stated, direct references to the February, 1935 LIBERTY MAGAZINE article about Nikola Tesla, plus other Tesla articles in the Dec. 8, 1915 NEW YORK TIMES and Sept. 22, 1940 NEW YORK TIMES.

The Eastlund-ARCO patent states that the apparatus will work by "initially transmitting electromagnetic radiation from the earth's surface, essentially parallel to and along NATURALLY-OCCURRING, DIVERGENT, MAGNETIC FIELD LINES, WHICH EXTEND FROM THE EARTH'S SURFACE THROUGH THE REGION TO BE ALTERED."
